



**EXHIBITOR INSURANCE REQUIREMENTS:**

All exhibitors are required to provide a Certificate of Liability Insurance (see example below) that includes the following information:

1. Commercial General Liability insurance with minimum limits of \$1,000,000 per occurrence and \$2,000,000 aggregate.
2. Policy must be effective 2/3/2011 to 2/8/2011.
3. Duke Energy Convention Center, Cincinnati, OH, Trade Show Management: Reaction Management, Inc and Paisano Publication, LLC, dba V-Twin Expo must be listed as additional insureds.
4. Certificate will include at least 10 days notice for cancellation.
